Carport alley way ice and snow issues Town of Telluride Mike Bordogna updated the members noting that the county is working on a new ADA access to the courthouse and parking space next to the galloping goose. Town of Telluride will be paving the north side and east west alleyways next summer so the county will wait to make their improvements. The Town will require the utilities to be moved underground so the building owners will need to share the costs of this expense.
